Preamble

Article I: Nationalist Party's Guiding Philosophy

The Nationalist Party embraces a centrist civic nationalism rooted in the enduring values of liberty, justice, and equality. Our ideology is not defined by ethnicity, race, or cultural heritage, but by a shared commitment to the American principles of self-governance, individual rights, and collective responsibility. Article II: Immutable and Foundational Principles Immutable Definition of the Nationalist Party

This definition is immutable and shall never be altered under any circumstances.

Immutable Principles of the Nationalist Party

Article IV: Membership

I. Eligibility for Membership

To become a full member, individuals must:

- ii. Acknowledge the **Pledge of Nationalist Commitment**, affirming their dedication to the Party's principles and mission.

- iv. **Promote Opportunity for All** Advocating for a society in which every citizen, regardless of background, has the opportunity to contribute to the strength and progress of our nation.
- v. Engage in Civic Responsibility Actively participating in the democratic process, supporting reforms that promote fairness, accountability, and transparency in governance.

II. Membership Rights and Responsibilities

Rights of Members

- i. Full members (18 and older) have the right to vote in internal elections.
- ii. Members can hold office within the Party, subject to the necessary qualifications.
- **iii.** Members have the right to participate in decision-making processes and contribute to Party discussions.

Responsibilities of Members

- i. Members must uphold the Party's principles, ensuring their actions align with its mission.

Until a formal leadership structure is established, the Founder shall serve as leader pro tempore and may appoint an Executive Advisory Council to offer guidance. Future leadership structures must remain centrist, accountable, and in alignment with this Charter. Article VI: Code of Conduct and Ethics

All members and leaders of the Nationalist Party are expected to conduct themselves with integrity, honesty, and a commitment to national unity. The Party rejects corruption, extremism, and divisive rhetoric, standing instead for pragmatism, accountability, and responsible governance.

The **Code of Conduct and Ethics** will govern enforcement mechanisms, ensuring that all members uphold the Party's principles in their actions and public engagement.

Article VII: Amendment Process

The Nationalist Party Charter is a living document that may be refined to strengthen governance and adapt to the needs of the movement. However, the Party's immutable definition and foundational principles, as outlined in Article II, shall remain unalterable under all circumstances. Any amendments to the Charter must align with these principles and require approval by a two-thirds majority of recognized members.
